Charlotte moved, Earl seconded to approve the following consent agenda:

A roll call vote was called for: Earl – aye, John – aye, Charlotte – aye, and Kurt – aye.

Approved three in favor.

BJ presented an ordinance amendment he drafted regarding District Regulations in Title 10. This will amend section 10-7-3 of the city code to allow a special use permit to be considered for a church to operate in a Heavy Commercial zone. Kurt moved, Charlotte seconded to suspend the reading of Ordinance #539 and read the title of Ordinance #539 once. Approved three in favor. Earl read the title of Ordinance #539 in full. Earl moved, Kurt seconded to adopt Ordinance #539 amending the city code to allow churches to be considered for a special use permit in a Heavy Commercial zone. Approved three in favor.

Glen Russell commended the city for their snow removal efforts. He said he felt since the new Public Works Director took over, the streets have been taken care of much better than with the former Director. Mr. Russell said the citizens appreciate the way the snow removal was handled.

Tracy Osburn discussed the cost of LED Christmas lights compared to the large bulbs the city has been using. He felt LED lights could reduce the city's budget, and the lights will eventually pay for themselves.

Earl moved, Kurt seconded to approve the attached General Business Licenses for 2010. Approved three in favor.

Sandy presented a comment sheet Bingham County Planning and Zoning sent regarding a special use permit for Phyllis Wade to operate a daycare for up to twelve children. The Council had no concerns or comments.

Sandy said there will be a phone demonstration for a new telephone system for city hall on January 18, 2011, at 10:00 a.m. at Idea Com's office in Idaho Falls. She said she will send a reminder to everyone that might like to attend.

Sandy said the server for the Laserfische was hit by a power surge and the surge protector was evidentially worn out. She said the motherboard and one of the drives are destroyed. She received a bid of approximately \$900 for a new server. Sandy said this type of expense has been budgeted for. The Council felt a new server should be purchased.

Dawn said the city received a \$1000 grant from Basic American Foods for a new diving board at the city pool.

Dawn said she is still working on obtaining information for a new spray park.

Sandy said Forsgren has prepared a grant application for funding from DEQ for a new water storage tank. The Council felt the city should pursue a grant or loan through DEZ for the construction of a new water storage facility as recommended in the city's water facility planning study.

Alan said the camera has been installed in the police department foyer for the safe place designation. He said this information should be publicized.

Dawn said there are two participants in this season's Biggest Loser that resides in Shelley. She said some citizens who felt the city should support the residents on the show publicly have approached her.

Kurt said he attended the School District's Maintenance Facility meeting. He said the school is proposing another levy to raise the first levy from \$250,000 to \$375,000. He said this will not affect citizen's property taxes. Kurt said the school will be having more informational meetings on this matter.

Kurt said the veterans will be hosting a spaghetti dinner for military families this Friday at the Senior Citizens Center.

Earl said the Urban Renewal Board met today to discuss various projects that will attract new businesses to the city. He said they are also looking for new projects for the Urban Renewal Agency.

Charlotte said she spoke with the Youth Committee and asked them to think of ways to notify their peers regarding the use of the safe place vestibule.

John thanked the city employees for a great job done in snow removal, and thanked the other departments as well.

John expressed his thoughts for the families in the shooting tragedy in Tucson Arizona.
