I believe the proper role of government is to protect the citizens in the enjoyment of life and property. I oppose to many of the existing city codes. Using the reasoning that snow removal is an issue I feel that I can be handled differently with information and natural consequences, the argument of the possibility of devaluating property does not justify restricting someone's property rights. The following are what I feel are the principals involved:

Liberty: A two-car garage and paved parking may be a good idea for some and even most but private property rights would let the owner decide if he wants the two-car garage and that parking.

He should be informed of the snow removal ordnance and property value and he can then decide.

Government: Mrs. Cole resided a quote. I do not feel that government has the right to take property away over the issue of the two-car garage and whether the parking is in front of it.

Shelley government officials do not have the right to tell property owners how to invest their finances in their housing and property.

This may be appropriate for a neighbor hood but not for the whole city.

I feel that the consequences of this will be higher construction cost and rent. Garages add to construction cost and mortgages. This could affect a family with only one income or families with a fixed income and or low income.

City officials should be able to make recommendations but not legislate or take away property rights.
