Earl moved, Jeff seconded to approve the following consent agenda:

Building Permits:

A roll call vote was taken: Earl- aye, Jeff-aye, and Adam-aye. Approved three in favor, Kim absent.

Vaughn Rasmussen from Rocky Mountain Power was not in attendance.

Rod said a few years ago he discussed furthering education and the benefits of on-line education for law enforcement personnel. He said Officer Tincher recently finished his bachelor's degree in criminal justice and his advanced certificate from the Police Academy. Rod said he would like to recognize and congratulate Officer Tincher for his accomplishments. Mayor Pascoe complimented Officer Tincher on his accomplishments and bettering himself. Officer Tincher thanked the administration for their support, and also to his family for their help and support. Officer Tincher thanked his wife for her support, and said she is also completing an on line course that will be finished in May. Earl said he appreciates what Officer Tincher has done, and said he is very proud of him.

Myler MacCormack addressed the Council to discuss a School Class Service Project. He said he is looking for ideas that could be presented to Dale Clark, the principal at the Shelley High School. Mr. MacCormack said he wanted to thank the Mayor and Council for their service and making a difference in this town. Dawn suggested helping with the clean up at the Goodsell Elementary Playground. She said they have been working to clean up the playground

equipment. Mayor Pascoe said they would keep Mr. MacCormack in mind for anything that may come up.

Jeff moved, Adam seconded to approve the attached new business licenses for 2015. Approved three in favor, one absent. (list attached)

Earl moved, Jeff seconded to approve the attached business license renewals for 2015. Approved three in favor, one absent. (list attached)

Sandy presented a comment sheet she received from Bingham County regarding a CUP to allow an additional dwelling on a parcel of property. This property was quite a ways from the city limits and the Mayor and Council has no concerns or comments.

Earl moved, Adam seconded to cancel the Council meeting scheduled for December 23, 2014 due to the holidays. Approved three in favor, one absent.

The Mayor and Council gave permission to close City Hall at noon on December 24, 2014, and hold the annual employee luncheon.

Sandy said the health insurance contract will be renewing in January. She said some of the employees are able to meet the guidelines for the health insurance exchange except for being able to be carried as a dependant on the city's insurance. She said she talked to Ryan Anderson and the city could choose to not allow dependants on their policy which would give them eligibility for the insurance exchange. Sandy said at this time there are no employees that carry their dependants on the city's insurance because of the high cost. Rod said by taking the dependant eligibility off of the City's policy, it may allow him more hiring opportunities. Jeff moved, Adam seconded to eliminate dependant eligibility on the City's health insurance policy. Approved three in favor, one absent.

Mayor Pascoe said he would like to discuss the ordinance regarding mobile food vendors. At a prior council meeting the Board discussed amending the ordinance to have stricter regulations in place, and to support the brick and mortar businesses. Earl said he is all for supporting the brick and mortar businesses, but he also believes in free enterprise. He suggested possibly generating different regulations. Jeff said he had the opportunity to talk to a few people, and he doesn't want to limit business. He said he is against door to door sales, but that is due to safety issues on private property. Adam said he is torn between the two issues; he wants to protect the brick and mortar businesses, by if there is competition that is good and produces quality products. Jeff asked if there is substantial damage proven to brick and mortar businesses by mobile vendors. He said he is also concerned over the constitutionality of not allowing mobile vendors in the city. The Council decided this would be addressed and possibly the ordinance amended at the next council meeting. Sandy and BJ were directed to obtain information from the attorney list and some surrounding cities and present the information to the council.

BJ said the city received an appeal for an unemployment decision, and he feels we presented a good case. This was favorable for the city and the decision was upheld.

Sandy said the target date for Pizza Hut to open is December 16, 2014.

Sandy said she received a letter from the Idaho Department of Water Resources and the water permit 27-12155 has been extended until 11/1/2018.

Sandy said the AIC Conference in Boise has been changed from the third week in June to the second week in June. She said the conference will be held June 10th through the 12th. The Mayor and Council directed her to make room reservations for those dates.

Dave said he has received signed releases for two of the property owners affected by the construction of the North Water Line Loop. He said the Eatons have not signed the release and will be meeting with the contractor, Jerome Bowen to discuss other options. Dave said there are a few punch list items that need to be completed still; a fire hydrant needs to be raised eighteen inches, and a mail box in front of the storage units needs a cement base installed. He said Jerome Bowen Construction will be fixing these items next week.

Dawn said there are twenty Junior Jazz teams from Kindergarten through Second Grade. She said they will be using the Sunrise gym to play in.

Rod thanked all of the Department Heads and staff for their support. He also thanked BJ for a job well done in regarding to the unemployment appeal. Rod said he appreciates the decision the Council made regarding health insurance and dependant eligibility.

Chuck said the Christmas lights are up and will be turned on at 5:00 p.m. Friday. He said the crew has gotten the equipment ready for the snowfall also.

Chuck said ITD called and said the lights for the crosswalk on Locust and State have arrived. He said they will be installed by the city crew next spring.

Adam said congratulations to Officer Tincher for his accomplishment. He said this takes a lot of self motivation. He said thanks to the city crew as well.

Adam said the city went live with the app, however there were some issues and had to be taken off line. He said he will get it fixed and it will be back up again soon.

Jeff also congratulated Officer Tincher. He said it takes fortitude and a great employee to further their education.

Jeff thanked the Mayor for the opportunity to work with the Bingham County Economic Development Agency. He said they have started a group including Grow Idaho, and Bannock Development to become a regional entity. He said this

will allow the entity to market itself as such. Jeff said he thinks this will benefit this area.

Earl said he attended the AIC training two weeks ago in Idaho Falls. He said he received worth while information, and had the opportunity to meet people from other communities.

Earl thanked Office Tincher for everything he does for the city. He said we are lucky to have the people we have working for the city. Earl said he appreciates the job well done with the unemployment issue also.

Mayor Pascoe thanked Officer Tincher. He said he appreciates all of the Department Heads and feels the city runs great. Mayor Pascoe said he doesn't get many complaints about the city and he has been hearing positive comments. He said he appreciates Adam working on the app for the city, and Jeff for the work he has done with the Bingham County Economic Development Agency. He thanked Earl for his work and relationship with the Police Department. Mayor Pascoe thanked everyone for making him look great.
