Kurt moved, Earl seconded to approve the following consent agenda:

Minutes of September 25, 2012 Council Meeting

Building Permits:

Josh Jones – remodel Earl Beattie - fence

A roll call vote was called for: Stacy – aye, Kurt – aye, Jeff – aye, and Earl – aye. Approved unanimously.

Rui Bing Liang addressed the council to discuss the unoccupied sewer rate of \$35.16 that she was recently charged for an empty rental unit. Ms. Liang said she feels that being charged for an empty rental unit is not fair. She said the water to the entire building flows through one meter. She said the unit is available to rent, but nobody is in there at this time. Ms. Liang said there is a floor covering business that may want to expand into this empty unit. Sandy said if both units are rented by one person there is only one ERU charged for that type of business. Ms. Liang said she would talk to the owner of the floor covering business. She said he is storing a few items in the unit, but she is unsure if he will want to rent it. Mayor Christensen explained the debt service of the community, and said she will be charged the unoccupied rate if the unit is empty or expanded from two units to one. Ms. Liang felt that the city is money hungry, and this is not fair. Jeff explained that this is the law, and she will be charged for the unit unless two units are made into one unit only. In the future she could change it back to two units and rent both.

Sandy said she has received three letters from property owners who once had rentals in their homes, but no longer do. All three homes are zoned to be able to have at least a two family dwelling. Sandy said the letters state that the homes have been converted into single family residences. She said since the zoning allows it they may be converted back if the owner decides to. The Council discussed several ways to handle this; the property owner could request a zone change to Single Family Dwelling, or the Building Inspector could inspect the property to see that it has actually been converted to a Single Family Dwelling. The Council discussed having an agreement signed by the property owner stating that the property is no longer being used as a rental, and if the city discovers it is being used as a rental then the owner would be assessed for sewer charges back to the date of the agreement. Jeff moved, Earl seconded that a property owner in a zone where Two Family Dwellings are allowed, and were once using it as a Two Family Dwelling, but they are using the dwelling as a Single Family Dwelling at the present, can

avoid paying an unoccupied base sewer rate by signing an agreement stating they no longer intend to rent. If the agreement is breeched then they will be assessed for sewer back to the date when the agreement was signed. Approved unanimously. Sandy asked if the home on the corner of East Fir and South Milton could be waived from paying the unoccupied rate since the building is uninhabitable. The Council agreed.

Chuck said he has six stop signs that he would recommend be declared as surplus property. Kurt moved, Earl seconded to declare six stop signs as surplus property to be sold at auction.

Approved unanimously.

Sandy said there is a person who called to ask what zone a pet crematorium is allowed in. She said she cannot find any zoning that fits this type of business, and wondered if the Council wanted to amend the zoning ordinance. Sandy said she spoke with the Shelley Veterinary and they said they take all of their animals to Bonneville County. She said she also spoke with Bonneville County who has a pet crematorium. They indicated it is very costly to set up and maintain this type of business, and it is regulated by the EPA. The Council discussed this further and determined that they would like to talk to the potential business owner to see how serious she really is about constructing a crematorium. Sandy said she will contact Mel Middleton and have her come before the Council.

Sandy said she has been working with Text Wire to see about setting up text notifications for the public. She said she has been using a demonstration account and found that you could set up your alerts or notifications by city wide, council, employee, recreation, etc. The Council discussed the benefits of using Text Wire, and how many people might utilize this service. Jeff said he would like City Hall completely accessible to those who want it. Sandy said for the first 10,000 messages it would cost \$350, and the bulk messages would be good for one year. Jeff moved, Stacy seconded to approve the expense of \$350 annually to have Text Wire available to the public for city notifications. Approved unanimously. The Council also discussed having the ability to pay for city services on line. Sandy said she will be using a demonstration from Pay Port to provide this service.

Sandy said she had received an email and spreadsheet showing what Shelley's portion is for the remainder of the treatment plant project. She said Shelley is responsible for approximately 27% of the project, and there was a shortage of funds over the bond amount due to the expectation of private user's contributions. Sandy said according to the spreadsheet, the city owes approximately \$459,000 more. She said this amount includes the screening and water line project that has not been done yet. Sandy said she didn't feel comfortable paying for a portion of a project that has not been done, and we could wait until the next fiscal year to get an exact amount. She said the final pay out was figured to be paid out in the old fiscal budget, but there is enough in contingency to pay it in the new year. Jeff discussed the water line that is proposed to be put in to the lift station which will reuse the treated water. He said this line could possibly be extended to the farmer's field to the west so he would have access to the reclaimed water. Jeff said there is currently a deep water well that the farmer is using and it may be possible for the

city to use that water right associated with that well if the farmer has other means to irrigate which would be the reuse water. Jeff said he would talk to the engineers and EIRWWA regarding this matter.

Sandy said she contacted Daniel Parker of Union Pacific, and he stated that the city would not have to pay for a survey or any expenses until Union Pacific approved the proposed sale, and a price was negotiated. She said she has not heard back from Mr. Parker to see if Union Pacific has given the approval to negotiate.

Sandy said Intermountain Gas will be hosting an Energy Forum on October 17, 2012, if anyone is interested in attending.

Sandy said the City received a \$300 grant from the State for Arbor Day.

Chuck said Fall Clean Up will be held from October 15th through October 19th this year. Chuck said the Kiwanis club has donated \$2000 to move the power from the lights at the park down to the plugs. He said Purcell Electric brought in some transformers to help. He said the Kiwanis purchased two transformers for \$900. Chuck said this additional power can also be used for Christmas lights, but the Foot Ball Field lights cannot be used at the same time.

Jeff said a citizen approached him about having a smoke free park. The Council discussed this and felt this type of ordinance would be difficult to enforce. Jeff said he wondered what the others member's opinions were on this issue. Dawn said the City of Blackfoot is trying to come up with an ordinance prohibiting smoking at Jensen's Grove. The Council decided to address this issue further once Blackfoot has resolved theirs.

Stacy said he has received a complaint from a property odor on Country Club Road regarding the sewer odor. He said he drove out to the location after the last council meeting and there was a terrible smell. Stacy wondered why the screens that are being proposed could not be located closer to Ammon. He felt the city need to be pro-active and get something done about the odor complaints.

Mayor Christensen said he met with Sally Hartert and Susan Strickler regarding the Medicare Annual Open Enrollment. He said they are trying to get the word out that senior citizens need to re-enroll. Mayor Christensen said he is issuing a proclamation stating the Medicare Annual Open Enrollment will be October 15th through December 7th this year.
