A roll call vote was called for: Lorin - aye, Charlotte - aye, John - aye. Approved three in favor, one absent.

Nick Montana of Big Bear Construction said he is the contractor for Gables Management. He said the assisted living center is almost complete, and would like permission to create a landscape berm along the property adjacent to West Fir. He said he would also like permission to access city water to irrigate the landscape year round, instead of using irrigation water during the time the water is available in the canal. Sandy said the Development Agreement states that city culinary water is only to be used when there is no irrigation water available, and their backflow prevention device must be certified annually. BJ said the city is trying to show the State that we are taking steps to conserve water. In his opinion he would not recommend allowing the use of culinary water for landscape irrigation year round. The council determined that Gables Management would not be allowed to use culinary water for irrigation purposes year round. They will be allowed to used culinary water for irrigation only when there is not water in the canal due to the season. Rick said regarding the berm, that is a landscaping issue and he did not see any problem with it. The council agreed and said as far as the city is concerned there is no problem with putting a landscape berm on their property. Mike Carter said in behalf of Rocky Mountain Power they cannot bury a power pole in a berm because the wood is only treated so far up. Mr. Montana said they would like to begin construction on the town homes planned for the development soon. He said the water and the sewer lines have been tied into the city system, and the street paving should begin next week. Rick said he gave Mr. Montana permission to reduce the asphalt to 3 inches, the crushed rock to 6 inches, and the pit run to 10 inches for the street construction. Sandy reminded Mr. Montana until the infrastructure has been completed and accepted by the city, they cannot begin construction on the town homes.

Sandy said Carol Garrison from DEQ contacted her regarding the grant for the Water Facility Planning Study. She said the grant states that an environmental study may be needed for the water facility planning study. Sandy said the city has to agree that they are willing and able to pay a 50% grant match of approximately \$10,000 to \$30,000 for the environmental study portion. John moved, Charlotte seconded to approve an expenditure of approximately \$10,000 to \$30,000 for an environment study for the Water Facility Planning Study. Approved three in favor, one absent.

Sandy said according to State Statute, the city must provide the date of the new fiscal budget hearing to the County Clerk by April 30th. Appropriate dates were discussed. John moved, Lorin seconded to set the 2008-2009 Fiscal Year Budget Hearing for September 2,2008, at 7:30 p.m. Approved three in favor, one absent.

BJ said the city's water right application has been protested, and the mitigation plan was not accepted by the protestors. He said the next stage is to set a hearing with the Idaho Department of Water Resources (IDWR). BJ said at the last council meeting he was directed to obtain some information regarding the cost estimates concerning the hearing. He said the approximate cost to obtain an attorney who specializes in water issues and a hydrologist is \$10,000 to \$20,000. BJ said he discussed the hearing with Rob Harris, and Jerry Rigby who feel the signs at this point are pretty positive at the likelihood of success, but there has been no commitment from IDWR. BJ recommended the city hire Rob Harris as the attorney to represent the city during the water rights hearing since he is already familiar with the issues. He said Ball Development has indicated that they will pay Mr. Harris's attorney fees and the Easter Idaho Water Coalition has also pledged support in this endeavor. BJ said if the hearing goes in the city's favor there may be a chance that the protestors will appeal. He said there will be a pre-hearing scheduled before the actual hearing, and the tentative hearing date has been set for May 28, 2008 at the IDWR office in Idaho Falls. John recommended that AIC be contacted regarding this matter and asked for financial support as well as looking for any other additional support available. Lorin moved, Charlotte seconded to proceed with a hearing regarding the city's water rights application and to retain Rob Harris as the attorney that will be representing the city in this matter. Approved three in favor, one absent.

Wes Cook, Forsgren discussed the application to transfer the city's water rights diversion points to one point. He said this is taking all of the existing water rights and creating one new diversion point that will be known as well #5. This means all of the water rights could be pulled from any well. Wes said this will allow the city to drill a firm capacity well without going through the procedure to obtain more water rights. He said this will allow the city to begin drilling a new well, and if new water rights are obtained after the IDWR hearing then this new well could be used in that capacity. Wes felt it may be a good idea to talk to the senior water right holders before the application is submitted so they fully understand that the city will not be pulling more water from the aquifer. Lorin moved, Charlotte seconded to submit the application to IDWR to change the city's water right diversion points to one well. Approved three in favor, one absent.

Dave Noel said the bid opening for the Oxbow Treatment Plant was held today, however approval of the design is still needed from the Army Corp of Engineers. He said hopefully approval will be given this week. Dave said the low base bid came in at \$17.3 million. He said the budget information was approximately 16 million which was for a 2 million gallon per day treatment train. He said this included some of the infrastructure that the City of Ammon needs. Dave said the low bidder is RSCI out of the Boise area. The other two bids came from Alder and Bodell, both out of Salt Lake City. Dave said the dredging will begin on Monday the 28th of April. He said EPA has approved the draining of cells B and C. He said approximately 1 million dollars were saved by being able to drain both cells at this time. Dave said he will have a bid recommendation for the Regional Authority on Thursday at their meeting.

Ralph Powell introduced himself as running for the District Seat #2 in the Bingham County Commissioners race. He gave a brief biography of his life which included farming and working as an accountant. Mr. Powell said he has experience in budgets and financing. He said his goals are to build a State Veteran Cemetery in Bingham County and to be more active in the fight against meth.

There was a brief discussion regarding overnight parking on the streets in the Central Business zone. Lorin said he has received some complaints. Currently there is only two hour parking on State Street from Center Street to Emerson and no overnight parking. Alan said the only person that is violating this ordinance is Debbie Evans who has a special use permit to live in her business on State Street. No other further action was taken on this item.

Sandy said Bingham County sent two comment sheets for the city's review. The first is for a special use permit for Eduardo and Candy Gonzalez to have a temporary second dwelling on their lot in an A zone. The second is fro Gil Putnam in Hallmark Estates to split his two acre lot into two one acre lots. The Mayor and Council have no comments on these issues.

BJ clarified the proposed water ordinance amendment regarding water meters. It is determined that all new development and properties that have water valve repairs or replacements will be required to install water meter bases, and the ordinance will be amended as such.

Sandy presented a base engineering contract for Forsgren engineering. This base contract specifies obligations of each party for certain engineering services, such as subdivision review, inspections, mapping, etc. BJ will review the contract and return his comments at the next council meeting.

Dawn said the "Dare to Dance" event was held April 19, 2008. She said it was a great success and there was a lot of youth attendance. Everyone had a lot of fun.

Dawn said she is beginning the baseball program.

Rick said he and his crew are preparing for Arbor Day which will be held May 17, 2008. He said they are working on the triangle park so trees can be purchased and planted. Rick said they intend on seeding the park, and may possibly install a water feature during the next budget cycle.

Alan said the police department is in the middle of the Aggressive Driving Task Force week. He said the cities, counties, and state are participating in this task force. Alan said he has received a few telephone calls from upset citizens regarding police stops.

Alan said there was an incident with a dog at Brinkman Park last Saturday night. He said Officer Tincher received a complaint about a dog chasing children at Brinkman Park and responded. Officer Lewis was off duty and returning from running at the High School with his children when Officer Tincher asked for his assistance to catch the dog. The dog went after Officer Lewis's children and Officer Tincher tasered the dog. When Officer Lewis went to grab the dogs collar it turned and bite his hand. Officer Tincher then tasered the dog once again which caused the dog's jaw to clamp shut. Alan said currently Officer Lewis has a finger broken in two places that will be pinned on Friday. He said the dog belonged to Mike Hillman and he has been served a notice of intent to euthanize, and given a "dog at large" citation. It is unknown how long Officer Lewis will be unable to return to work.

Charlotte said she appreciates the city crew for picking up the garbage along the streets and the work they have been doing to clean up the Butte.

Charlotte said the Key Club will be picking up trash along a five mile stretch on the Interstate.

John said he met with Diane Mickelson regarding Riverfest. He said he would like to have a city booth at the event staffed by members of the Tree Committee and others individuals that would work on community involvement with the update to the comprehensive plan. John said he has heard concerns from the public over the growing number of multi-family dwellings in our community. He wondered if there could be a ratio formulated to the number of multi-family dwellings compared to the number of single family dwellings that could be used as a policy. Sandy said there are not that many areas left inside the city limits that are zoned as multi-family dwellings. She said this matter could be reviewed when an application for annexation and rezone is submitted.

John said a Jet Boat and Wake Board competition are being considered as an event at Riverfest. He asked if the city should have a waiver for liability drafted. BJ said yes, if the city is sponsoring the event. Dawn said she would send BJ a copy of the Skateboard competition waiver to see if it could be used for the water competitions.

Lorin introduced his son, Jared Croft who has just returned from serving in the Navy for six years.

BJ discussed the workshop that he had with the Planning and Zoning Commission. He said he needs to provide the P&Z members with a list of criteria to use when they are reviewing non-conforming use application for undue hardships. BJ said he will create some guidelines for the Board to use.

Lorin said he appreciates the city for the flowers that were sent to his brother who was in the hospital.

Lorin said there will be a SICOG meeting in Aberdeen on Thursday night that he will be attending.

Lorin said Brent Christensen has sold some property to the church who would like to access city water and sewer. This property could possibly be annexed and there may be a number of water rights that could be transferred to the city.

Lorin said the poles have been installed along the river that will be used for habitat nesting. He said they have not been occupied by birds yet.

Mayor Christensen said there will be a regional waste water meeting held Thursday, April 24, 2008, at 10:00 a.m. He invited all to attend.
